

**The Fear PDX Blackout 2022**  
**Liability Waiver Form**

I represent and promise that I am in good physical condition and fully able to participate in this event. I am fully aware of any and all risks and hazards connected with my participation in this event, including but not limited to injury to or loss of property, physical injury or even death. By signing this agreement, I agree that I am choosing to voluntarily participate in the Blackout 2022 event, with full knowledge and understanding that this event and the physical activity associated with this event may be hazardous to my property and me. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, DAMAGE OR INJURY TO PROPERTY OR PERSON, INCLUDING DEATH, that I might sustain or experience as a result of participation in this event.

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, Scream Haunted Enterprises LLC dba The Fear PDX, their officers, owners, landlord, Members, contractors, agents, and employees (hereinafter referred to as RELEASES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in the Blackout 2022 event, or while on or upon the premises where the event is being conducted.

It is my expressed intent that this indemnification, release and hold harmless agreement shall be binding on both me and the members of my family, spouse, heirs, assigns and personal representative, and shall be deemed as a RELEASE, WAIVE, DISCHARGE, and COVENANT NOT TO SUE the above named RELEASES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of the state in which this event is being held.

FURTHER, I AGREE AND ACKNOWLEDGE THAT IN PARTICIPATING IN BLACKOUT 2022, I AM DOING SO AT MY OWN RISK. I HEREBY AGREE AND ACKNOWLEDGE THAT SCREAM HAUNTED ENTERPRISES LLC dba FEAR PDX WOULD NOT ALLOW ME TO PARTICIPATE IN BLACKOUT 2022 WITHOUT FIRST SIGNING THIS RELEASE, AND THAT THIS RELEASE BE APPLIED AND ENFORCED TO THE FULLEST EXTENT UNDER THE LAWS OF THE STATE IN WHICH THIS EVENT IS TAKING PLACE OR ANY OTHER STATE WHICH MAY HAVE JURISDICTION OVER A MATTER RESULTING FROM THIS AGREEMENT.

I declare that I have carefully read this Agreement, fully understand its contents, that the document is a release of all liability in a court of law, that I am signing it of my own free will and that the foregoing is true and correct.
